

Second Hand Uniform Shop Terms & Conditions As of 22 August 2022

Placing items for sale in the FODH Second-Hand Uniform Shop confirms your acceptance of the following terms and conditions

1. FODH is **only accepting “new style” clothing and bags** for sale. We **will also accept gently used sporting equipment** (i.e., cricket pads and hockey sticks). We **will not accept shoes, “old style” uniform or kit, or any other non-Danes Hill branded items.**
2. All items submitted for sale must be cleaned and clearly and legibly labelled with the following information:
 - Full Name
 - Date
 - Item Name/Description
 - Size
 - Price

Please note your email on the back of each ticket to ensure we can contact you with any questions.

We recommend all labels are affixed using a safety pin to ensure against loss of the label. Pursuant to Clause 7 below, if a label is not affixed properly and is lost, the item will be considered a donation and the proceeds of its sale will benefit FODH as described in Clause 4 below. **Please ensure that the name noted on the label matches that of the school’s records to expedite payment.**

3. The second-hand shop offers a suggested price list (available on request). These prices are just a guide, and you are responsible for the pricing of your items.
4. In addition to selling items on your behalf, FODH also accepts donations of the items described in Clause 1 above. In this case **100% of the proceeds of the sale of such items will be retained by FODH** in its fundraising efforts. These items do not need to be labelled but should be cleaned prior to donation.
5. FODH reserves the right to refuse to accept any items which are of poor quality, damaged, badly marked or stained.
6. FODH is not authorised to change the price of any item you have submitted for sale without your permission.
7. FODH is not responsible for any loss or damage to any item submitted for sale including, but not limited to, theft, missing sale label or any “force majeure” event that may affect the shop and its premises.

8. FODH does not maintain an inventory of clothing either to be sold or donated. **Once items are placed in the shop, you will not be able to retrieve any items you placed for sale.**
9. **All sales are final.**
10. Any items not sold within two years or are otherwise deemed obsolete will be donated to charity.
11. **You are entitled to 60% of the amount for which your item sells** subject to Clauses 2 and 10 above after which you relinquish all claims and rights, and items are then considered fully donated to FODH.
12. The FODH payment policy for items sold in the shop are as follows:
 - If your children are still attending the school, any sale proceeds from the FODH shop are deducted from the Autumn and Spring term school fees.
 - If all your children have left the school, any sale proceeds are initially refunded via the school fees billing process in the Autumn and Spring term to the bank account that was previously used to pay fees. When this is no longer possible, FODH would like to be able to transfer any sale proceeds directly to your bank account. Please provide bank details to fodhshop@gmail.com to expedite this process.
